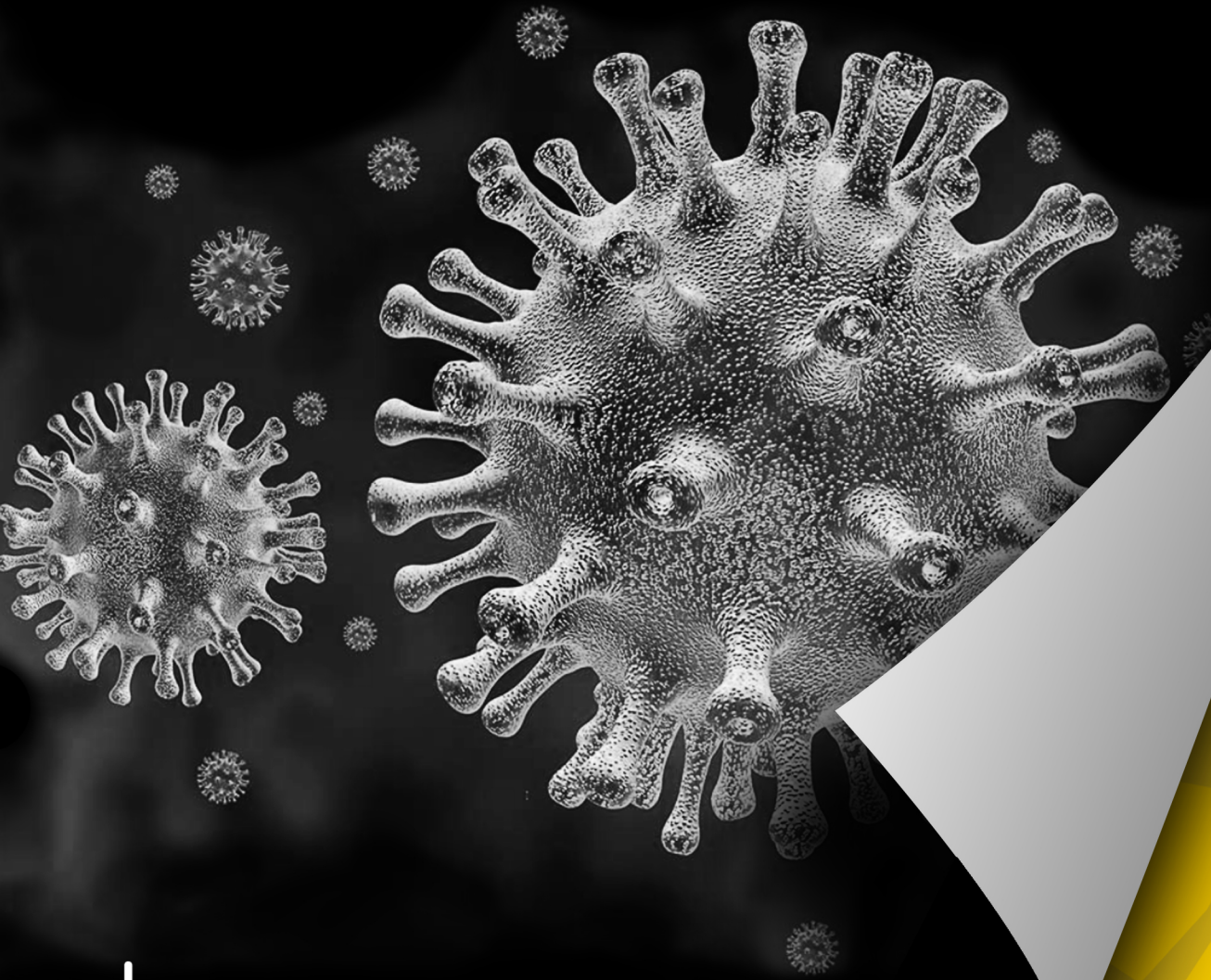

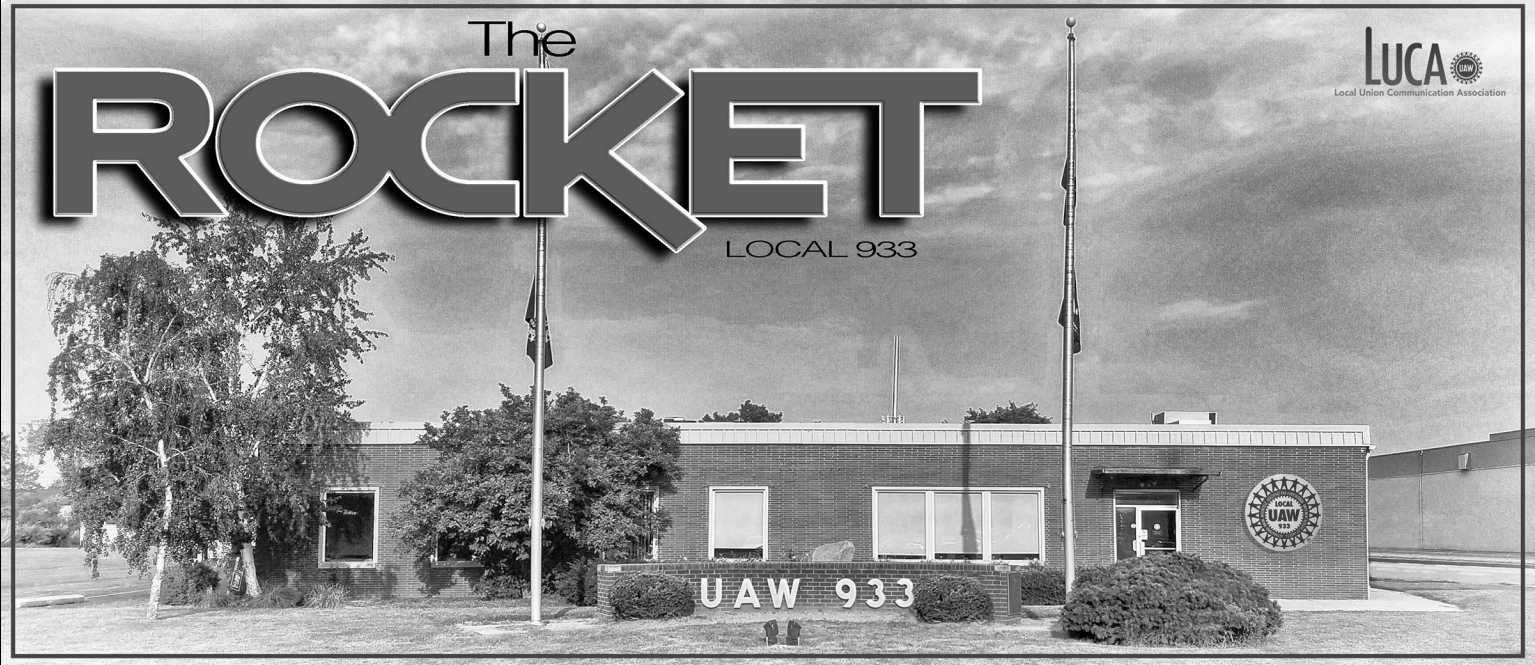

Adapting to COVID-19

Who could have seen this coming? Obviously not the World Health Organization. This really makes us step

back and look at things in a different light. From the concerns with jobs and incomes, to the uncertainty of what tomorrow brings, Covid-19 has left its mark. No one could have predicted what we would face since the first reported case hit in the U.S. on March 5, 2020. We saw the empty store shelves and toilet paper (of all things!) becoming a great commodity. People were buying 200 pounds of meat and you could not trade a gold bar for some hand sanitizer. More importantly, people's livelihoods were being taken away with state-ordered sanctions to restrict travel and social gatherings. As of today, those are for the most part, still in place. The U.S. has lost some 70,000+ lives and reported 1.21 million confirmed cases of the corona virus with those numbers growing daily. Most of our membership has been affected in some way, even to the extent that loved ones have lost their lives. According to MARKETPLACE.org, unemployment could reach 20 percent as nearly 30.3 million people have filed initial claims over the last six weeks.

Due to supply issues, the aerospace industry has been decimated by the virus. Restricted air travel has caused the airlines to cut engine orders on a broad scale. Rolls-Royce globally has been asked to reduce its 52,000 workforce by some 8,000 employees, as well as global pay cuts and other reductions. Fortunately, Rolls-Royce Indy has been blessed with defensive work which has kept the doors open and standard hours maintained keeping employee jobs from being reduced. We are on the front lines providing parts and engines to C-130 aircraft as well as helicopter engines that assist with police and fire rescue.

With a new five-year collective bargaining agreement in place, we are poised to do our part in supplying our best customer the U.S. military. We have to adapt to the change by being safe and taking all precautions as we gradually get back on our feet.

Thank you, Local 933 Membership, for your patience as we work through this together. We may not be the cure but we can definitely be a part of the answer.

UAW REGION 2-B RICHARD T. GOSSER SCHOLARSHIP FUND

The Richard T. Gosser Scholarship Program accepts applications from the daughters and sons of UAW Region 2B members. The ACT test is required. If the student has not previously taken the ACT, they should sign up to take the ACT test and have your test scores sent to our office by listing our code number 9894. Finalists are based on ACT scores and will be notified in writing. As a finalist, applications are assessed by a team of prominent community leaders and educators, who then select the winners based on ACT scores, class rank, extra-curricular activities, letters of recommendation, personality traits and leadership abilities. Documentation regarding class rank, extra-curricular activities, letters of recommendation, personality traits and leadership abilities are required from all finalist, but not required with the initial application. The Call letter and Application for the 2021 Graduating Class will be available on the Region 2B website <http://region2b.uaw.org> in August 2020. The application must be either received by the Region 2B office or postmarked by October 15, 2020.
