

A candidate must be a member in good standing for one (1) year immediately prior to the nomination. Please have your union card or Plant ID on Election Day. Election conducted per the provisions of the International Union, UAW Constitution, Local 933 Bylaws and Local 933 Election Committee. The term of office shall be effective upon the day immediately following the June 2025 Membership Meeting until the General Election in May or June of 2028. In the event of a tie, a runoff election will be held **Tuesday**, **June 10**, **2025** at the same polling sites and hours.

#### **UAW PRESIDENT SHAWN FAIN VISITS LOCAL 933**

What a great way to end 2024 and come out strong at the beginning of 2025. UAW International President Shawn Fain came to Local 933 on December 3, 2024 (see cover photo) to speak and visit with UAW Local 23 retirees at their Christmas Meeting/luncheon and also took time to meet with Chairman John Snow and the Rolls-Royce Shop Committee. President Fain reassured our bargaining team that they had his full support and the support of Region 2B Director Dave Green along with the Aerospace Dept. in Detroit, as our Maywood bargaining unit is currently

in contract negotiations with the Rolls-Royce Company. A week later guess who shows up again? You got it, President Shawn Fain along with Region 2B Director Dave Green. The return visit was to meet with the Local 933 Retirees at their Christmas Meeting/luncheon. They had scheduled enough time during their second visit to tour Rolls-Royce which is a very impressive Aerospace facility.

The message to the Retirees from President Shawn Fain touched on several key elements.

Never taking for granted all the work done by the members and retirees for laying the ground work of our great union he stated that "our Retirees are our secret weapon." If you get everything you ask for in bargaining, you did not ask for enough. We will be vocal about our objectives and our demands. We must eliminate two words from our vocabulary: Can't and Fear. We were told we can't bargain for retirees; we did! We were also told we can't bring cost of living back and we can't get the largest wage increase in history and many others. We delivered on every one of them. We were told we can't organize Volkswagen; we did! We ran a campaign against the CEO of Stellantis and he stepped down. We bargained over one billion dollars for Retiree benefits and security. Our retirees will not be forgotten as we move forward.

#### THE IAC DROP-IN CENTER FOR UAW RETIREES IS HERE!

What is IAC? It's the Greater Marion County International Area Council which was established because the Retirees in our geographical area need assistance with medical bills, pensions, life insurance, etc. The UAW has a constitutional mandate which provides an opportunity to establish IAC and drop-in centers to Retirees. A special thank you to Region 2B Servicing Representative Petra Jameson! Petra advocated strongly for the drop-in center which gives an opportunity for all UAW Retirees in the geographical area to come together and meet to discuss issues which impact them directly. The Retirees in the Marion County area haven't had a representative to assist them with closed locals since 2019. Petra and I have been working on establishing the drop-in center here for about a year and it's been a hard-fought journey to make sure the Retirees have the resources needed. The IAC can assist any UAW Retiree in the area whether your benefits come from GM, Ford, Chrysler (Stellantis), or even Navistar. Please note, retirees receiving their benefits from Allison Transmission or Rolls-Royce still have full time representatives here at the union hall for their assistance. All Retirees are welcome to attend the Greater Marion County International Area Council (IAC) meetings which are held on the 4th Thursday of the month starting at 12:00 noon here at UAW Local 933, 2023 South Tibbs Avenue, Indianapolis, Indiana 46241. The IAC Counselor, Robin Heiskell, will be available every Wednesday and Thursday, 11:00 am – 3:00 pm, at Local 933 with the exception of holidays. Without the help of Sister Jameson, our Indiana Retired Workers Representative, this program would not have been possible. This program MUST BE USED or it will be taken away so please share and spread the word to all UAW Retirees. This is help for Retirees that's well deserved and long overdue, thank you for a job well done.

AFRICAN AMERICANS AND LABOR

This year's Black History Month, "African Americans and Labor," is a powerful reminder of the critical roles African Americans have played in various labor movements. Their efforts in organizing for better working conditions, equal pay, and the end of discriminatory practices have left an indelible mark on history.

The Thibodaux Massacre on November 23, 1887, in Thibodaux, Louisiana, is a stark example of the struggles faced by African American

laborers who went on strike demanding better wages and improved working conditions. The strike was organized by the Knights of Labor which lasted for three weeks and incorporated close to 10,000 sugar cane workers, most of whom were African American. Tensions escalated during the strike when white paramilitary forces and state militia attacked the striking workers and their families. The violence resulted in the deaths of at least 60 African Americans, with many more injured or missing. This tragic event effectively ended the unionization efforts of black sugar cane workers in the South for decades.

African American Pullman Porters also played a significant role in American labor history. After the Civil War, George Pullman began hiring African American men, many of whom were former slaves, to work as porters on his luxury railroad sleeping cars. Despite the demanding and often demeaning nature of their work, Pullman porters became a symbol of dignity and resilience. In 1925, under the leadership of A. Philip Randolph, the porters formed the Brotherhood of Sleeping Car Porters (BSCP), the first predominantly African American labor union. The porters faced harsh working conditions, low wages, and racial discrimination. Their efforts laid the groundwork for the modern Civil Rights Movement and significantly contributed to the development of the Black Middle Class in America.

The Memphis Sanitation Workers' Strike of 1968 was another significant event in the Civil Rights Movement, highlighting the struggle for workers' rights and racial equality. The strike began on February 12, 1968, following the deaths of two sanitation workers, Echol Cole and Robert Walker, due to dangerous working conditions. Over 1,300 African American sanitation workers went on strike, demanding better pay, overtime pay, safer working conditions, and union recognition. The strike gained national attention and support from civil rights leaders, including Martin Luther King Jr., who delivered his final speech, "I've Been to the Mountaintop," in Memphis. King's assassination the following day intensified the focus on the strike, which ended on April 16, 1968, with the city of Memphis agreeing to the workers' demands. This strike underscored the intersection of labor rights and civil rights, leaving a lasting impact on the fight for economic and racial justice.

In conclusion, "African Americans and Labor" for this year's Black History Month, serves as an influential reminder of the significant contributions and sacrifices made by African Americans in the labor movement. From the tragic Thibodaux Massacre to the resilience of the Pullman porters and the impactful Memphis Sanitation Workers' Strike, these events highlight the ongoing struggle for workers' rights and racial equality. Their legacy continues to inspire and shape the fight for justice and equality in the workplace and beyond.

Despite the challenges faced by the labor movement both historically and today, the importance of labor unions cannot be overstated. They have been instrumental in securing better working conditions, diverse workforce, fair wages, and securing the rights of workers across various industries. The fight for economic and racial justice continues, and labor unions remain a vital force in advocating for the dignity and well-being of workers. We must continue to support and strengthen these efforts to ensure a more equitable and just society for all.

When you speak of negotiations there is always talk of the Shop Committee but know one works harder than the elected officials who are in the facilities fighting the daily fight. I would personally like to thank each Committeeperson and Alternates for the jobs they do daily taking care of the memberships needs. Also, a special thank you to the appointed ranks who support the committee on a daily basis and our membership who work so hard in the factories every day. We will need everyone to stick together as we fight to bring a good contract to our membership. Our contract ends February 26, 2025 and although a strike is never a good situation to be in, it is always something to be prepared for to help ensure a fair and equitable agreement will be reached.




