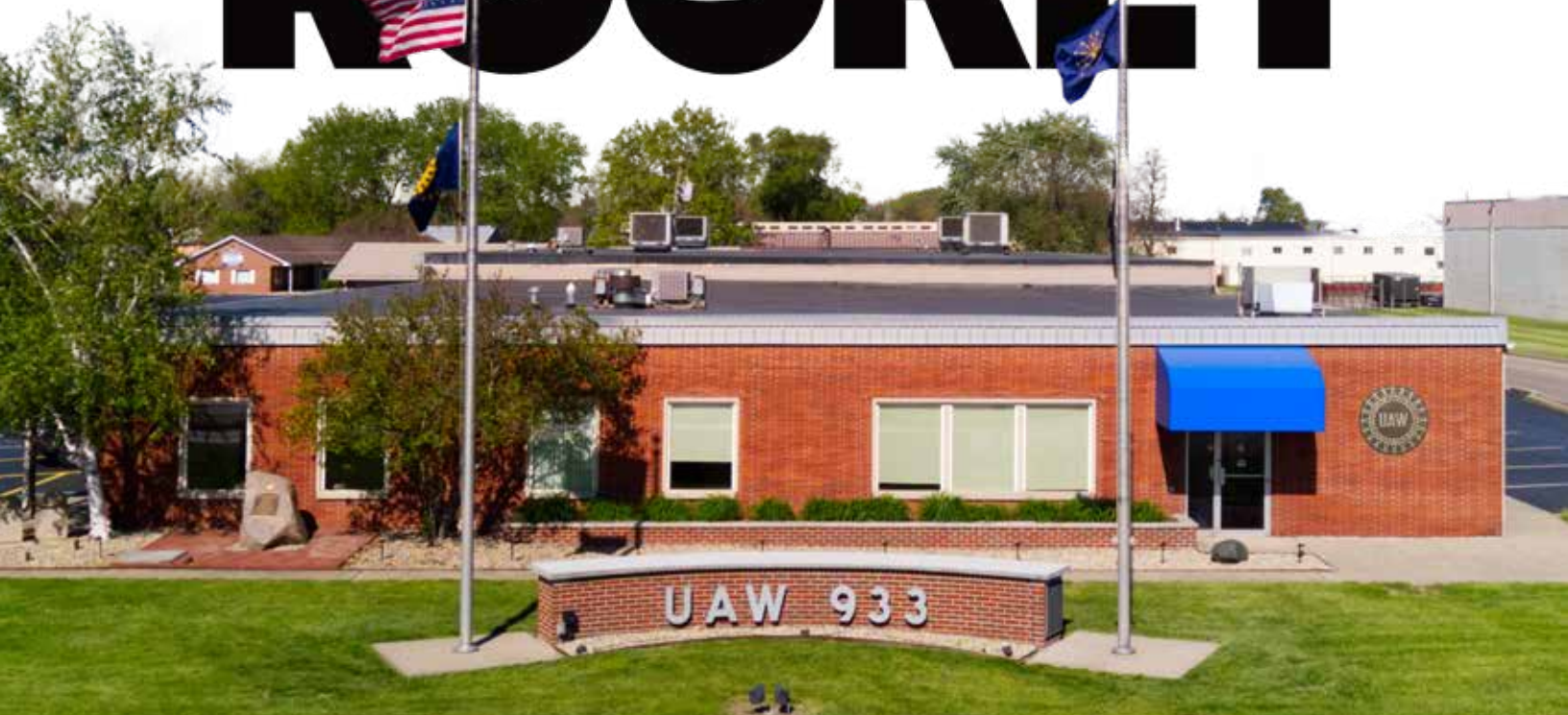

One of our other Administrative Assistants, Nancy Holle, passed away on May 30, 2025. Nancy was the admin assigned to the front lobby, answering the phones and assisting the Chairpersons and Retirees along with many other duties that were assigned to her. After 37 years of service at UAW Local 933, Nancy will be greatly missed.

With temporary reassignment of work to the administration here at the union hall, I want to give a special thank you and notice the Executive Assistant to the President's office, Sandy Reichle, for absorbing the bulk of the extra work load as we move through these changes. 2026 SCHOLARSHIP PROGRAM

The Richard T. Gosser Scholarship Program accepts applications from the daughters and sons of UAW Region 2B members. The ACT test is required. If the student has not previously taken the ACT, they should sign up to take the ACT test in the coming months and have your test scores sent to our office by listing our code number **#9894**.

Finalists are based on ACT scores and will be notified in writing. As a finalist, applications are assessed by a team of prominent community leaders and educators, who then select the winners based on ACT scores, class rank, extra-curricular activities, letters of recommendation, personality traits and leadership abilities. Documentation regarding class rank, extra-curricular activities, letters of recommendation, personality traits and leadership abilities **are required from all finalist**, but not required with the initial application.

The Call letter and Application for the 2026 Graduating Class will be available on the Region 2B website in July 2025.

LABOR DAY 2025



Labor Day, observed on the first Monday in September, is a national tribute to the social and economic achievements of American workers. As we approach this holiday in 2025, a central question arises: are the nation's current economic policies truly honoring this legacy? The recent implementation of new tariffs and a deeply concerning jobs report suggest that American workers are facing significant new challenges.

The holiday's origins trace back to the late 19th-century American Industrial Revolution, a period of immense hardship where workers endured 12-hour days in unsafe conditions. In response, labor unions like the Central Labor Union of New York organized the first Labor Day parade in 1882, demonstrating the power and solidarity of American labor. It was a powerful message that continues to resonate today.

The President's administration has imposed new tariffs on goods from major trade partners with the goal of protecting American industries. However, this policy is met with skepticism from economists who warn that these tariffs could cost the average American family up to \$2,400 a year and raise production costs for factories, potentially leading to layoffs. These rising costs could lead to businesses halting new hires or laying off workers; the opposite of what is needed to honor American labor.

This situation echoes one of the most significant policy errors in American history: the Smoot-Hawley Tariff Act of 1930. This law triggered a global trade war that caused international trade to plummet and worsened the Great Depression. The lesson is a stark reminder that policies intended to help American workers can backfire, leading to widespread economic hardship.

As we prepare to celebrate Labor Day, we must look beyond the parades and picnics and consider the true state of American workers. The holiday's original purpose was to celebrate the strength and resilience of labor. Today, with the threat of higher costs, a weakening job market, and the ghost of Smoot-Hawley looming, we face a crucial question: how can we genuinely honor American workers when the policies meant to protect them may be making their future so uncertain?

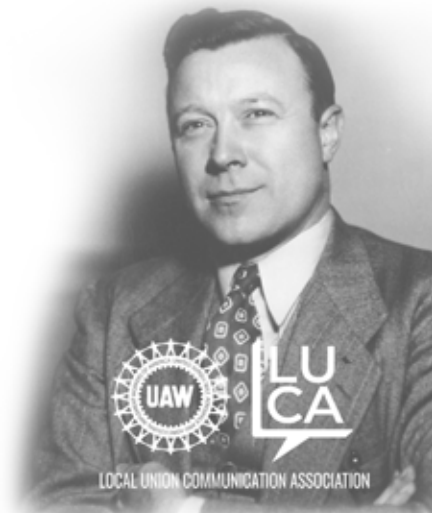
