RULES: All hunting laws of Indiana will be complied with. You must enter 2020 season to be eligible for prize. Winner will be decided by combination of weight, *beard and spur length. Any ties will share equally in prize. **Entries must be paid seven (7) days prior to a turkey check-in.**

**The longest beard will be counted, i.e. double beard (longest beard).*
