

# <u>Stand Up and</u> <u>Stand Together</u>

One of the most common questions I get asked is how will the Big 3 contract negotiations affect us here at Local 933 Rolls-Royce? As tentative offers are being voted on, we are beginning to see the fruition of the UAW stand-up strikes. Of course, no one likes tier wages or past negotiations that took cost of living, decent healthcare benefits and pensions away from workers. When those items were negotiated away, it was in part due to the health of the individual businesses to rebuild and face a global economy that put companies in a better position to compete. What we have seen with the Big 3 is a rebound and record profits in the billions. UAW President

Shawn Fain has clearly stated the workers have helped that turn around and it is time to reward them. What each negotiator must account for is the health of the business. It becomes pointless to negotiate past a ceiling that results in an aftermath of outsourcing and plant closures. Each facility is unique, and each industry faces competition that may be distinctive. It is very important that your negotiating team understands and studies ways to keep the so-called golden goose alive and well. I have personally seen negotiations where half the work in the factory is being sent out and layoffs are abundant. We have all seen giant factories around us close and be scraped to the ground.

Negotiations are never easy and being able to see potential ways to grow the business and put better opportunities in front of your negotiating team will result in better bargaining power at the table. I can assure you our bargaining team will compare other contracts as well as our evolution here in Indy as we move toward our next set of negotiations. New military contracts for the B-52 engine and V-280 will certainly help as well as the investment in the facilities, but ultimately more new work will be needed to keep good paying jobs with good benefits and a future for our workers. If the companies are winning, it is the union's responsibility to ensure the workers are winning too.

What can each of you do to support our union? First off: Become educated on your local and national contracts. It is important to understand what has been negotiated. Get involved in your union through union meetings, committees and events that help show union solidarity. Lastly, realize that union dues help support strike funds, community action, and help keep our local/national union strong and working for you. Today, all our members pay union dues except two. Thank you for not scabbing on our union like they do.

I would like to give our Local 933 Allison Transmission Brothers and Sisters all our support and prayers as you work through contract negotiations. We stand with you! Please wear red on Wednesdays as a show of support.

As we move into November 2023, I would like to recognize and thank our Veterans for all you have done to help secure our freedoms. Working in a defense plant that helps support those efforts brings an even greater importance to the role we all play keeping America safe. The UAW elected and appointed representatives would also like to wish you and you families a blessed Thanksgiving and Christmas Holidays.

# STRIKING CORPORATE AMERICA

As we go about our days, occupied with our own affairs, it is difficult to ignore the recurring scene coming across our television screens of employees from yet another corporation striking their employers in protest. This year has seen a significant surge in organized labor, with workers and unions joining forces to demand better wages and working conditions from corporations enjoying record profits.

The decision to strike is never an easy one, especially as workers, already stretched financially, face an unknown and potentially long period without income and without the assurance of a favorable outcome. Nevertheless, when workers finally reach the breaking point and employers continue to turn a deaf ear to their pleas, the time to act has arrived. In this year alone, approximately 390,000 workers have initiated strikes in response to deteriorating working conditions, low pay, and contentious employer-employee relations. Workers are organizing, mobilizing and protesting to turn the tide.

On May 2, 2023, Writers Guild of America (WGA) members took to the streets in protest following six arduous weeks of negotiations. The WGA represents nearly 11,500 writers involved in the American entertainment industry's film sector. The WGA strike came to a close on September 27, 2023, a strike that lasted 148 days and had an estimated economic impact of \$3 billion.

On July 14, 2023, the Screen Actor Guild – American Federation of Television and Radio Artists mimicked the WGA's actions by taking to the streets after unsuccessful negotiations regarding job security. Even now, the SAG-AFTRA remains on strike while negotiations continue.

On September 15, 2023, the UAW, representing over 145,000 members nationwide, initiated a targeted StandUp Strike against specific segments of the Big Three automotive industry. Rather than pulling all employees out on strike, President Shawn Fain focused on certain facilities to create a significant supply chain disruption, resulting in downstream layoffs. At the time of this writing, all entities of the Big 3 have a tentative agreement pending membership ratification.

On October 2, 2023, Allison Transmission and UAW Local 933/ATI Division initiated contract negotiations. The contract is set to expire on November 14, 2023, and despite the absence of progress, the Union maintains optimism for a fair and equitable agreement, similar to other UAW sectors and the Big Three.

We must not forget the sacrifices made by the UAW during the monumental 2007 bankruptcy to sustain Corporate America. Corporate America not only survived her dark night by leaning on her workers, she thrived and continues to thrive while her workers have been asked again and again to take concessions. The time has arrived to balance the scales. The workers have given enough. We are resolute in our stance, and we will hold our ground. The workers have made it possible for ATI to consistently achieve record-breaking profits, and it is high time for those profits to be reflected in our wages and in the monthly checks received by our retirees.

As we stand in Solidarity and Unity, let 2023 be a year marked by the absence of concessions.


