**RULES:** All hunting laws of Indiana will be complied with. You must enter 2023 season to be eligible for prize. Winner will be decided by combination of weight, \*beard and spur length. Any ties will share equally in prize. **Entries must be paid seven (7) days prior to a turkey check-in.**

*\*The longest beard will be counted, i.e. double beard (longest beard).*

### \$100 Youth Season Prize

18 years-old or younger, still in high school (child, stepchild, grandchild or step-grandchild of member)  
**Youth winner is eligible for Regular Season Prize.**
